

**PARTNERSHIP AGREEMENT
RELATIONS BETWEEN
R. GLIER KYIV MUNICIPAL ACADEMY of MUSIC
AND
THE KRZYSZTOF PENDERECKI ACADEMY OF MUSIC
IN KRAKÓW**

21.01.2025, Kraków

R. Glier Kyiv Municipal Academy of Music, represented by Rector **Dr Oleksandr Zlotnyk**, on the one hand, and the **Krzysztof Penderecki Academy of Music in Kraków**, represented by Rector **Prof. Dr Hab. Mariusz Sielski** together hereinafter referred to as the «Parties», have entered into this Cooperation Agreement (hereinafter «Agreement»):

1. GENERAL PROVISIONS

1.1. The Parties are acting on the basis of mutual interest in the joint development of their educational scientific and creative potential, including joint educational and science-creative projects.

1.2. The cooperation is based on equality, mutual benefit, honest business partnership, as well as maintenance of mutual business contacts.

1.3. The present Agreement shall not impose any property and financial liabilities on each Party, and any restrictions on their independence and autonomy while exercising their statutory activities.

2. SUBJECT OF AGREEMENT

2.1. The subject of the Agreement is the organization of the partnership and cooperation of the Parties.

2.2. The Parties will promote the deepening of Ukrainian – Polish relations in the cultural sector through the exchange of experience in teaching methods, creative achievements and research.

2.3. The Parties will promote common cultural rapprochement, development of creative potential, better acquaintance with the cultures of both countries.

2.4. The Parties will promote joint organization and holding of international events (cultural, educational and artistic projects, master-classes, concerts and lectures, workshops) and academic (scientific) conferences (symposiums, seminars), as well as preparing joint publications on the materials of these conferences, and other academic and journalistic publications.

2.5. The Parties will exchange their most talented students of all specializations of the specialty «Musical arts» through academic mobility.

2.6. The Parties will carry out the exchanges of teachers in the form of:

- master classes, guest courses, seminars;
- participation in scientific and creative projects, academic conferences, music festivals and competitions;
- participation in the preparation of joint publications;
- participation in the implementation of joint artistic projects and events;
- participation in collaborative arts and education projects, programs or events.

2.7. The Parties will promote the exchange of group and solo performers within the financial capacity of each of the Parties.

2.8. The Parties will promote the exchange of teachers and staff with the aim of improving their professional development through participation in educational and research activities of the institution where the internship (training) is taking place (the internship requires a separate agreement).

2.9. The Parties are interested in receiving information on international music festivals and competitions that are held in their countries that are based in or were organized with the assistance of the Parties.

2.10. The Parties will also exchange information about their most important events, their structure, educational programs.

3. AMENDMENTS

3.1. The Parties agree that this Agreement may be amended and supplemented by the addition of separate protocols, which will constitute an integral part of the Agreement.

3.2. All changes and additions to this Agreement shall be made in writing and signed by the both Parties.

3.3. The development and implementation of specific activities based on this agreement will be separately negotiated and be a subject of a separate written agreement between the two Parties.

4. FINAL PROVISIONS

4.1. This Agreement shall enter into force upon signature and will be valid for 5 years. It will be automatically extended for the next 5 years, unless one of the Parties informs the other Party in written form about its intention to terminate it no later than 30 days before the end of the Agreement.

4.2. This Agreement may be terminated by either Party by a written notice. This agreement shall be terminated within 2 (two) months from the date of receipt of the written notice.

4.3. The Agreement is drawn up in English.
